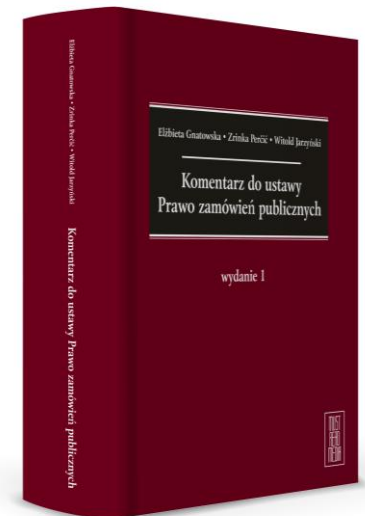
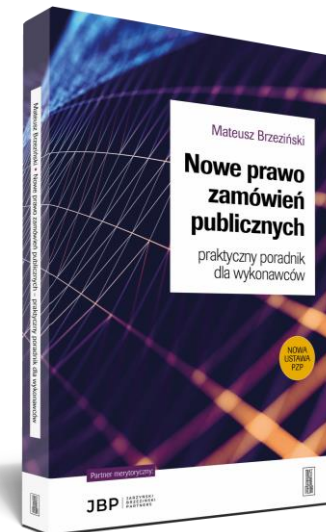
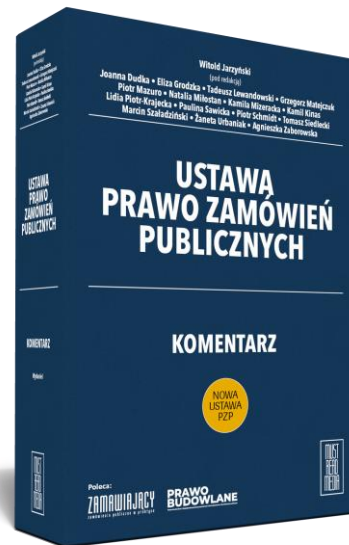
A graduate of the Faculty of Law and Administration at the University of Silesia in Katowice (law).
